FIRST AMENDMENT TO PURCHASE AND SALE AGREEMENT

(Northtown Property - Bargain Sale Transaction)

This First Amendment to the Purchase and Sale Agreement ("Amendment") is made and entered into as of the date of the last signature below, by and between Scott McDonald, an individual, and Bottom Feeder International, Inc., a Nevada corporation (together, "Sellers"), and Amador-Tuolumne Community Resources, Inc., a California public nonprofit corporation ("Buyer"), with reference to the following facts:

RECITALS

- WHEREAS, the Parties entered into that certain Purchase and Sale Agreement dated August 15, 2025 (the "Agreement"), for the sale of the real property commonly known as 427 North Highway 49 / 59 Columbia Way, Sonora, California, and more particularly described in Exhibit A of the Agreement;
- WHEREAS, the Agreement recites that, according to an appraisal dated July 14, 2025, the fair market value of the property was \$1,510,000;
- WHEREAS, a corrected version of the appraisal has since been issued, establishing the updated fair market value as \$1,500,000;
- WHEREAS, the Parties desire to amend the Agreement solely to reflect this revised appraised value;
- NOW, THEREFORE, in consideration of the mutual covenants and promises set forth herein, the Parties agree to amend the Agreement as follows:

1. Amendment to Recitals

The third "WHEREAS" clause of the Agreement is hereby deleted and replaced with the following:

"WHEREAS, the fair market value according to a corrected appraisal dated August 22, 2025 is \$1,500,000.00, and Seller Scott McDonald is offering Buyer to sell his 90% interest, which he values at \$1,350,000.00, at a discounted price of \$315,000.00, with \$1,035,000.00 representing a charitable contribution;"

2. No Other Changes

Except as expressly modified by this Amendment, all terms, conditions, rights, and obligations set forth in the Agreement shall remain in full force and effect without modification.
